**ORDINANCE NO: 05-04**

**AN ORDINANCE REPEALING ORDINANCE NO. 01-05; ESTABLISHING NEW RATES TO BE CHARGED FOR THE USE OF COUNTY WATER WORKS SYSTEM, AMENDING ORDINANCE NO. 98-01 REGARDING RATES; INCORPORATING ORDINANCE NO. 98-01 IN ALL OTHER ORDINANCE PROVISIONS; PROVIDING FOR AN EFFECTIVE DATE THEREIN.**

**WHEREAS**, costs for supplying water and services in Liberty County have increased.

**WHEREAS**, the Board of County Commissioners of Liberty County has determined that it shall be necessary to repeal Ordinance No. 01-05, for the purpose of amending the rates of the water system.

**NOW THEREFORE BE IT RESOLVED AND ORDAINED BY THE BOARD OF COUNTY COMMISSIONERS OF LIBERTY COUNTY, FLORIDA, THAT ORDINANCE NO. 01-05 IS REPEALED; AND THAT SECTION 2 AND SECTION 13 OF ORDINANCE NO. 98-01 IS AMENDED; AND THAT ALL OTHER PROVISIONS OF LIBERTY COUNTY ORDINANCE NO. 98-01 ARE INCORPORATED HEREIN BY REFERENCE AND MADE A PART HEREOF:**

**The amendments to Ordinance No. 98-01 are as follows:**

**SECTION 2. Charge or Rate for Water Service** Any user of the services of the waterworks system shall pay a monthly charge or rate, as follows:

<u>Rates</u>	<u>Monthly Basis</u>
First 3,000 Gallons or less.....	\$12.50 (Minimum Bill);
Next 3,000 Gallons.....	\$1.85 per 1,000 Gallons;
Next 4,000 Gallons.....	\$1.50 per 1,000 Gallons;
Next 10,000 Gallons.....	\$.125 per 1,000 Gallons.

Connection Fee: After Construction, at least Two Hundred Fifty Dollars (\$250.00).

**SECTION 13. Effective Date** This Ordinance shall take effect as provided by law.
