ORDINANCE NO: 05-05

AN ORDINANCE REPEALING ORDINANCE NO. 01-06, AMENDING ORDINANCE NO. 00-01; PROVIDING FOR NEW RESIDENTIAL AND COMMERCIAL SERVICE FEES TO BE CHARGED FOR GARBAGE SERVICES BY LIBERTY COUNTY; INCORPORATING ORDINANCE NO. 00-01 IN ALL OTHER ORDINANCE PROVISIONS, AND PROVIDING FOR AN EFFECTIVE DATE THEREIN; .

WHEREAS, costs have increased in providing for the collection, transportation, and disposal of non-hazardous garbage, trash, and other waste for residences and business establishments within Liberty County.

WHEREAS, the Board of County Commissioners of Liberty County has determined that it shall be necessary to repeal Ordinance No.01-06, and amend Ordinance 00-01 for the purpose of amending the rates of the garbage disposal system.

NOW THEREFORE BE IT RESOLVED AND ORDAINED BY THE BOARD OF COUNTY COMMISSIONERS OF LIBERTY COUNTY, FLORIDA, THAT ORDINANCE 01-06 IS REPEALED; THAT "EXHIBIT A" OF ORDINANCE NO. 00-01 IS AMENDED; AND THAT ALL OTHER PROVISIONS OF LIBERTY COUNTY ORDINANCE NO. 00-01 ARE INCORPORATED HEREIN BY REFERENCE AND MADE A PART HEREOF:

Exhibit "A" of Ordinance No. 00-01 is amended as follows:

EXHIBIT "A":

Residential Service Fee for Garbage Service.

The initial residential service fee hereunder shall be fourteen dollars (\$14.00) per residence, per month.

Commercial Service Fee for Garbage Service.

The initial commercial service fee hereunder shall be:

Eighty-one dollars and eighteen cents (\$81.18) per month for each Four (4) cubic yard container.


Ninety-eight dollars and ninety-one cents (\$98.91) per month for each Seven (7) cubic yard container.

Fifteen dollars and sixty-three cents (\$15.63) per month for each Ninety (90) gallon container.

SECTION 32. Effective Date This Ordinance shall take effect as provided by law.
