AN ORDINANCE ESTABLISHING A DEPARTMENT OF SANITATION FOR LIBERTY COUNTY, FLORIDA, PROVIDING FOR THE FUNDING THEREOF, PROVIDING THE POWERS AND DUTIES OF SAID DEPARTMENT, PROVIDING FOR COUNTY WIDE GARBAGE COLLECTION, AUTHORIZING THE BOARD OF COUNTY COMMISSIONERS OF LIBERTY COUNTY, FLORIDA TO IMPOSE A CHARGE FOR GARBAGE COLLECTION, PROVIDING FOR THE MAINTENANCE OF COUNTY MAINTAINED GARBAGE DISPOSAL AREAS, AND PROVIDING AN EFFECTIVE DATE.

SECTION ONE: The Board of County Commissioners of Liberty County, Florida, has found and determined that there is a need for a County-wide garbage collection system and that the best interest of Liberty County, Florida will be served if the Board of County Commissioners provide this service.

SECTION TWO: There is hereby established a Department of Sanitation to be known as the Liberty County Department of Sanitation which shall be under the control of the Board of County Commissioners of Liberty County, Florida, and supervised and managed by the Liberty County Road Superintendent unless the Board of County Commissioners of Liberty County, Florida, shall, by resolution or motion designate some other manager.

SECTION THREE: The Liberty County Department of Sanitation shall have authority to purchase such equipment and engage such employees and incur such expenses as are approved by the Board of County Commissioners of Liberty County, Florida for the purpose of collecting and disposing of garbage and trash.

SECTION FOUR: All costs and expense of operating the Department of Sanitation shall be paid from Liberty County's General Fund; and the Board of County Commissioners of Liberty County, Florida, shall, commencing with the fiscal year 1974 budget funds for the Department of Sanitation.

SECTION FIVE: The Board of County Commissioners of Liberty County, Florida, may, in its discretion, by resolution, establish uniform charges to be made to persons utilizing the garbage collection service, and may limit the service to those paying such charges as may be prescribed by the Board of County Commissioners.

SECTION SIX: The manager or superintendent of the Department of Sanitation shall have authority to schedule collections in such areas of the county and in such manner as is practicable subject to review by the Board of County Commissioners. Said schedule of collections shall state the various areas of the county in which garbage will be collected and the days on which collection will be made

together with any requirements to be met by the users of the garbage collection service and shall be published in the Bristol Free Press.

SECTION SEVEN: The Board of County Commissioners may from time to time acquire by purchase, gift or otherwise, land upon which to construct garbage disposal pits or systems and provide for the maintenance and care thereof.
