

# Small Cities Community Development Block Grant (CDBG)

## Second Public Hearing & Fair Housing Workshop Notice

### LIBERTY COUNTY, FLORIDA

Liberty County plans to apply to Florida Commerce for a FFY 2023 Small Cities Community Development Block Grant (CDBG) in the Neighborhood Revitalization category for up to \$700,000. The activities, dollar amounts and estimated percentage benefit to low-and-moderate income persons are as follows:

Liberty County's proposed project activities will allow for four roads across the county to be resurfaced: Gobbler Court, Whitetail Court, Shawn Road and Williams Road. The existing pavement is in very poor condition, does not provide a suitable driving surface for residents in the service areas, and is prone to flooding and water damage during intense rain and storms. The condition of these roads will continue to deteriorate, leading to unnecessary wear and tear on residents' vehicles, which is a financial burden on low-to-moderate income level residents.

The County is also proposing an additional project as an unaddressed need which involves the resurfacing of Paul White Road (2,300 LF), located in unincorporated Hosford, FL. Should additional funding become available, this project may be eligible for potential funding.

Liberty County does not expect that anyone will be displaced because of CDBG-funded activities. If any persons are displaced because of the planned activities, the County will assist them as described in the County's anti-displacement and relocation policy, which is available for review at **Liberty County Courthouse at 10818 NW, SR-20, Bristol, FL**.

A **public hearing** to provide citizens an opportunity to comment on the application will be conducted in a handicapped accessible location in **the courtroom of the Liberty County Courthouse at 10818 NW, SR-20, Bristol, FL on October 24, 2024, at 6:00 pm**. A draft copy of the application will also be available for review during normal business hours at the **Veterans Memorial Civic Center at 10405 NW Theo Jacobs Way, Bristol FL** by noon on October 21, 2024.

A **Fair Housing Workshop** will be held on **October 24, 2024** at 6:00 pm in **the courtroom of the Liberty County Courthouse at 10818 NW, SR-20, Bristol, FL** to discuss local, state and federal fair housing laws.
