ORDINANCE NO. 91-03

AN ORDINANCE AMENDING LIBERTY COUNTY ORDINANCE NO. 91-02, TO ALLOW FOR MONTHLY BILLING TO GOVERNMENTAL AGENCIES FOR FEES FOR DISPOSAL OF WASTE MATERIALS AT THE LIBERTY COUNTY LANDFILL; PROVIDING FOR PROCEDURES FOR GOVERNMENTAL AGENCIES WHO DESIRE TO BE BILLED MONTHLY FOR DISPOSAL OF WASTE MATERIALS AT THE LIBERTY COUNTY LANDFILL; PROVIDING FOR CONFLICT AND SEVERANCE; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, Liberty County operates a landfill for the disposal of certain types of solid waste materials; and

WHEREAS, Ordinance No. 91-02 requires the payment of certain fees at the Liberty County Landfill for the use of said facility; and

WHEREAS, the fees are required to be paid at the time of the use of the landfill; and

WHEREAS, the Board of County Commissioners of Liberty County desire to allow for monthly billing and payment by governmental agencies; and

WHEREAS, the Board of County Commissioners of Liberty County desire to set forth the procedures for governmental agencies to follow to allow to be billed monthly.

NOW THEREFORE, BE IT ORDAINED by the Board of County Commissioners of Liberty County, Florida, that:

Section 1. Monthly Billing.

All governmental agencies, including city, county, state, and federal, who follow the procedures set forth in Section 2 will be allowed to utilize the facilities at the Liberty County Landfill without paying a fee for each time the governmental agency utilizes the landfill, but will be billed monthly by Liberty County.

Section 2. Procedures For Monthly Billing.

Governmental agencies desiring to be placed on the monthly billing list shall submit a request by their agency to the Liberty County Board of County Commissioners through the Clerk of the Circuit Court, who will then provide a list of those governmental agencies to the landfill manager at the landfill waste station site.

Section 3. Conflict. All Ordinances or parts of Ordinances in conflict with the provisions of this Ordinance are hereby repealed to the extent of such conflict.

Section 4. Severability. If any section, subsection, sentence, clause, phrase or portion of this Ordinance is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinct, and independent provision, and such holding shall not affect the validity of the remaining portions of the Ordinance.

Section 5. Effective Date. In accordance with Section 125.66, Florida Statutes, a certified copy of this Ordinance shall be filed with the Department of State by the Clerk of the Board of County Commissioners within ten (10) days after enactment, and this Ordinance shall take effect upon receipt of official acknowledgement that said Ordinance has been filed.
